Background

- In 2006, SEETO Steering Committee established an expert Working Group on Railway and Inter-modal policy
- On December 4th, 2007 the Addendum of the MoU regarding the South East Europe Railway Transport Area was signed at the Third Annual Ministerial Meeting
- On December 4th, 2008 the Time table for the implementation of Addendum was adopted on 4th **Annual Ministerial Meeting**
- In 2009, under the umbrella of SEETO, regional Railway reform project was carried out

JEEIO ...

Institution building



- railway licensing bodies responsible for issuing licences to railway undertakings;
- regulatory bodies in charge of allocating railway infrastructure capacity and levying charges for the use of railway infrastructure, and of safety certification;
- safety authorities
- incident and accident investigation bodies

Separation, management independence and market orientation

- Restructuring of railways into more commercially oriented companies
- Separation of transport services and infrastructure management
- Financial documents kept and published separately

JEE10

Fair infrastructure access, safety and interoperability

- Clear and transparent conditions for access to the rail infrastructure
- Maintain and further develop the existing high level of interoperability,
- Support rail safety by setting up safety targets and safety management system

JEETO

Financial Stability

- Placing railways on financially viable basis
- Introduction of annual and multi-annual contracts between the public authority and the Infrastructure Manger
- Public Service Obligation Contracts for compensation of passenger services

TEFT

Border crossing

- Reduction of excessive border crossing waiting times and facilitation of movement of passengers and goods
- Aligning bilateral border crossing agreements with EU legislation
- Introduction of joint border station, zone, passenger control on moving trains

JEE10

Rail reform projects in the region

- To provide insight in the various rail reform projects and studies done in the Regional Participants
- Full utilization of infrastructure investments and improvement of the overall transport system

JEETO

Identification of focal points in the rail reform process which need to be further addressed

- The proposals for further actions will be elaborated after consultations with the RWWG group
- Proposals will be based on recommendations and conclusions of the previos RWWG meetings and SEE Rail Reform Progress - report
