## The purpose of Regional Visits 2014

- Increase the visibility and presence of the SEETO Secretariat in the SEE region
- Improvement of data collection process
- **Special focus of Regional Visits 2014**
  - Mutual exchange of information and views on current on-going SEETO activities
  - SEETO Comprehensive Network infrastructure projects
    - Planned priority projects
    - Finance secured/ongoing/implemented
  - Horizontal policy issues



## The purpose of Regional Visits 2014

- To elaborate and discuss on certain horizontal (soft) measures
- To discuss on the SEETO Multi-Annual plan 2015
- Maintain good channel for communication
- To ensure the work of SEETO is further recognised, appraised and beneficial for the Regional Participants
- To share opinions and visions on furthering the regional cooperation process



## Structure of Regional Visits 2014

- It is proposed to organize several meetings in relevant institutions in each Regional Participant
  - **Ministry of Transport**
    - Steering Committee Members
    - National Coordinators
    - Personnel from all transport sectors (road, rail, air, inland waterway, maritime, road safety)
    - Public Enterprises (if necessary separate meeting could be organized)
    - **Ministries of Finance**
    - **National IPA Coordinators**
    - **Customs departments**
  - **EU delegations**

- Increased visibility of SEETO cooperation in all Regional Participants
- SEETO`s role is further recognised, appraised and beneficial for the Regional Participants
- Established information sharing channels among SEETO Secretariat and relevant institutions in Regional Participants
